

SPIA 上海浦东

- CAO's share of SPIA profit in 3Q decreased 29.3% year-on-year to US\$5.2 million 3季度CAO对上海浦东投资收益为520万美元,较上年同期减少29.3%
- Mainly due to higher procurement costs and lower revenue due to the recent decline in oil prices, higher interest expenses and exchange losses attributable to acute strengthening of Renminbi against the US Dollar 主要由于上海浦东采购成本较高,销售收入因油价下滑而有所下降,以及利息费用和人民币兑美元快速升值造成的汇兑损失增加所致



Taxation 所得税

- In 3Q 2008, received IRAS' confirmation: 2008年3季度收到新加坡国内税务局确认函:
 - Approximately S\$893 million (US\$530 million) of tax losses resulting from speculative options trading in FY2004 can be carried forward to offset against future assessable income;
 - 允许将2004年期权亏损约8.93亿新元(5.30亿美元)结转 至以后年度抵减应税所得;
 - ➤ Gain of US\$192 million recognised from the waiver of debts in FY 2006 is not taxable; 不对2006年债务重组计划下债务弃权确认的1.92亿美元收益征税;



Taxation 所得税

- ➤ Accordingly, reversed approximately US\$4.7 million of tax provisions provided previously; 据此,转回之前计提所得税约470万美元;
- ➤ Received a tax refund of US\$1.4 million from IRAS following successful claim under Group Loss Relief of its wholly owned subsidiary, CAOT.

 在集团全资子公司CAOT转回集团税务损失的申请成功后,收到新加坡国内税务局返还所得税140万美元。
