CAO Reports 1H 2023 Revenue of US\$6.28 Billion and Net Profit of US\$19.40 million

- Revenue declined by 32.42% to US\$6.28 billion, mainly due to the decrease in oil prices and volume. 由于油价和业务量下降,收入减少32.42%至62.8亿美元。
- Operating profit grew 10.23% while net profit eased 1.07% to US\$19.40 million, mainly due to a lower gross profit, partially offset by the increase in other income and decrease in expenses. 营业利润同比上涨10.23%,净利润同比下降1.07%至1,940万美元,主要是因为毛利低于上年同期水平,但得益于其他收入的增长及费用控制较好,抵消了部分降幅。
- Total supply and trading volume declined 16.06% to 9.46 million metric tonnes for 1H 2023 compared to 11.27 million metric tonnes for 1H 2022.

The Group maintains a healthy financial position with improved cash and cash equivalents of US\$534.35 million and zero net interest-bearing debt. Group Net Asset Value ("NAV") rose to 105.21 US cents per share as at 30 June 2023 from 104.97 US cents per share as at 31 December 2022.

SINGAPORE, **8 August 2023** – China Aviation Oil (Singapore) Corporation Ltd ("CAO" or "the Group"), the largest physical jet fuel buyer in the Asia Pacific region, today announced revenue of US\$6.28 billion and net profit of US\$19.40 million for the first half-year ended 30 June 2023 ("1H 2023").

2023年8月8日 新加坡讯 —— 亚太地区最大的航油实货采购商——中国航油 (新加坡)股份有限公司(以下简称"中国航油新加坡公司"或"公司")于今日公告,公司截至2023年6月30日(以下简称 "2023年上半年")的收入为62.8亿美元,净利润为1.940万美元。

Revenue declined by 32.42% on the back of lower oil prices and volume while gross profit fell by 50.55% to US\$10.65 million due to lower gains derived from trading activities. Operating profit, however, rose by 10.23% to US\$13.37 million due to an increase in other income and a decrease in expenses. Other income grew by US\$10.67 million, attributed mainly to higher interest income which increased by US\$8.76 million year-on-year. Exchange differences was US\$0.22 million for 1H 2023 compared to -US\$2.11 million for 1H 2022, an improvement of US\$2.33 million.

由于油价和业务量下降,公司2023年上半年的收入下降32.42%;毛利下降50.55%至1,065万美元,主要是贸易活动收益减少所致。得益于其他收入大幅增长及费用控制较好,公司2023年上半年的营业利润达1,337万美元,增幅为10.23%;其他收入增加1,067万美元,主要是利息收入同比增加了876万美元。2023年上半年的汇兑收益为22万美元,较上年同期的负211万美元增加了233万美元。

Net profit for 1H 2023 remained relatively stable - dipping slightly by 1.07% to US\$19.40 million, mainly resulting from the lower gross profit which was partially offset by the increase in other income and decrease in expenses.

Total supply and trading volume declined 16.06% to 9.46 million metric tonnes for 1H 2023 compared to 11.27 million metric tonnes for 1H 2022. The trading volume of other oil products decreased by 19.59% to 5.54 million metric tonnes for 1H 2023 compared to 6.89 million metric tonnes for 1H 2022, due mainly to lower trading volume for crude oil.



2023年上半年总业务量为946万吨,较2022年上半年的1,127万吨下降16.06%。 其它油品业务量较上年同期的689万吨减少19.59%至554万吨,主要是原油业务量减少所致。

Contribution from the Group's associates dropped by 14.65% to US\$8.26 million for 1H 2023 compared to US\$9.68 million for 1H 2022, mainly due to lower contribution from Shanghai Pudong International Airport Aviation Fuel Supply Company Ltd ("SPIA") which declined 15.90% to US\$8.78 million for 1H 2023, largely due to inventory impairment caused by the decline in oil price.

The Group's Earnings per Share ("EPS") remained stable at 2.29 US cents year-on-year. 2023 年上半年,归属于公司所有者的每股净收益为 2.29 美分,与上年同期持平。

The Group's financial position continued to improve as its cash and cash equivalents grew from US\$308.20 million as at 31 December 2022 to US\$534.35 million as at 30 June 2023 while maintaining zero net interest-bearing debt. Group NAV was at 105.21 US cents per share as at 30 June 2023 compared to 104.97 US cents per share as at 31 December 2022.

公司财务状况保持良好, 无任何带息负债, 其货币资金总额从 2022 年 12 月 31 日的 3.08 亿美元增加至 2023 年 6 月 30 日的 5.34 亿美元。截至 2023 年 6 月 30 日,归属于公司所有者的每股资产净值为 105.21 美分(2022 年 12 月 31 日: 104.97 美分)。

Mr Lin Yi, Chief Executive Officer/Executive Director of CAO, said, "CAO delivered a commendable performance for the first half of FY2023 against the backdrop of a challenging operating environment. We reckoned that the global operating environment for the second half of the year will continue to be challenging and difficult. However, with the Chinese Government's ongoing efforts to spur growth in international air traffic in the second half of this year, the recovery of international air passenger market in China is expected to accelerate. As such, the Group remains cautiously optimistic on its performance for the second half of the year".



中国航油新加坡公司首席执行官兼执行董事林奕先生表示: "尽管2023年上半年的经营环境复杂严峻,但是公司依旧取得了稳健的经营业绩。展望2023年下半年,虽然市场仍存在挑战及不确定性,但是中国政府将积极增加国际航班量,此举预计将加快中国国际航空客运市场的复苏。故此,我们对公司下半年的业绩状况持谨慎乐观态度。"

Mr Lin added. "In the months ahead, we will remain prudent in managing market risks and stay committed to strengthening operational resilience, building on jet fuel supply and trading network, complemented with trading in other oil products. We will also continue to focus on long-term profitability by seeking opportunities for strategic expansion through investments in synergetic and strategic oil-related assets and businesses."
